NOW, THEREFORE, it is hereby understood and agreed:

- The **Supplier** shall furnish, subject to the limitations set out in the rules and regulations, such quantity of water as the **Member** may need in connection with their occupancy.
- The **Member** this date agrees to make a deposit of \$100. The deposit shall be held and applied by the **Supplier** to the payment of the account of the **Member**, should service to the member be terminated, either voluntarily by **Member**, or involuntarily by the **Supplier**; and the balance of the account is unpaid. Should the account be fully paid at the time of the termination of service to the **Member**, the deposit shall be returned by the **Supplier** within a reasonable time thereafter.
- The **Member** pays this date a \$ 50 connection fee which is NOT refundable (*Connection fee is waived for a new meter-set*)
- New Meter Set paid by **Member** \$1,200.00 (*if applicable*)
- The **Member** agrees to pay a 10% late fee if their water bill is not paid by the due date EACH month.
- The Supplier reserves the right to disconnect service once the bill becomes fifteen (15) days past due. If water is disconnected for non-payment, the Member agrees to pay a \$100 reconnection fee plus the entire account balance.**

MEMBERSHIP MAY BE TERMINATED BY ACTION OF THE BOARD OF DIRECTORS WHERE THE USE OF PROPERTY IS CHANGED SO AS TO MATERIALLY INCREASE THE AMOUNT OF WATER CONSUMED TO THE PREJUDICE OF OTHER EXISTING MEMBERS OR TO THE PREJUDICE OF THE ORDERLY OPERATION OF THE SYSTEM.
